## **SUMMARY**

### **Offer Price and net proceeds**

The Offer Price has been determined at HK\$0.50 per Offer Share (exclusive of brokerage fee of 1%, SFC transaction levy of 0.0027% and Stock Exchange trading fee of 0.005%).

Based on the Offer Price of HK\$0.50 per Offer Share, the amount of net proceeds from the Share Offer to be received by the Company, after deducting the underwriting commissions, the SFC transaction levy, the Stock Exchange trading fee and the related listing expenses payable by the Company in connection with the Share Offer, is estimated to be approximately HK\$33.9 million. The Company intends to apply such net proceeds from the Share Offer in the manner as set out in the paragraph headed “Net proceeds from the Share Offer” in this announcement.

### **Applications under the Public Offer**

The Public Offer Shares initially offered under the Public Offer have been very significantly oversubscribed. A total of 7,465 valid applications were received pursuant to the Public Offer on **WHITE** and **YELLOW** Application Forms and through giving **electronic application instructions** to HKSCC via CCASS and through under the **HK eIPO White Form** service for a total of 276,230,000 Public Offer Shares, equivalent to approximately 22.10 times of the total number of 12,500,000 Public Offer Shares initially available for subscription under the Public Offer. A total of 2,577 applicants have been allotted with at least one board lot of the Public Offer Shares.

Due to the over-subscription in the Public Offer, the reallocation procedures as described in the section headed “Structure of the Share Offer – the Public Offer – Reallocation” in the Prospectus have been applied. As the number of the Public Offer Shares validly applied for in the Public Offer represents more than 15 times but less than 50 times of the total number of Public Offer Shares available under the Public Offer, 25,000,000 Offer Shares have been reallocated to the Public Offer from the Placing, so that the total number of Offer Shares allocated to the Public Offer has increased to 37,500,000 Offer Shares, representing 30% of the total number of Offer Shares available under the Share Offer.

### **Placing**

The Placing Shares initially offered under the Placing have also been moderately oversubscribed, representing 1.74 times of the total number of 112,500,000 Placing Shares initially available under the Placing.
